02. Old and rusted containers should not be used for transportation of ENA.
03. Each consignment will be checked as per the IS: 6613 : 2002 and unloaded if found suitable only.
04. Interested suppliers / manufacturers may submit their Quotation (F.O.R Aska) in sealed cover super scribing " QUOTATION FOR SUPPLY OF Extra Neutral Alcohol (ENA) 2022-23".
05. No Quotation will be accepted if sent by email
06. The F.O.R. rate shall include cost of Extra Neutral Alcohol (ENA) including all Taxes & Duties like GST/CST 2% against C-form / VAT/ Export fee of concerned State, Import Fee & transport fee per Bulk litre applicable for Odisha State as per the latest State Excise Policy 2022-23 and freight charges & transit insurance etc. excluding TCS.
07. The Quotation in sealed packet shall be received by the Aska Co-operative Sugar Industries Ltd. through **Registered Post / Speed Post / Courier Service** only till **5:00 PM of 24/03/2022**. The Quotation will be opened at **11:30 AM of 25/03/2022**. There shall have two phase evaluation of Quotaion (a) Technical Bid & (b) Financial Bid. Quotaton for technical bid with required document should be sent in a sealed cover superscribing " Technical Bid " The rate of ENA / Financial bid should be placed in another separate sealed cover superscribing "Finiancial Bid " for supply of ENA. Both sealed covers should be placed in another Bigger Sealed cover superscribing Quotation for Supply of ENA to ACSIL during 2022-23.


Technical Bid
