
The Aska Cooperative Sugar Industries Ltd., Aska invites sealed tenders from interested Manufacturer/Suppliers/Dealers having GSTIN for supply of *BURNT LIME, HDPPE BAG, LUBRICANTS, BOILER FUELS, CHEMICALS* as detailed at tender form along with specifications.

TERMS & CONDITIONS:

- i. The tender forms are available by down loading from the website of the Aska Coop. Sugar Industries Ltd www.askasugar.com. The cost of tender paper is ₹500/-(Rupees five hundred) only which is not refundable. The tenderer should deposit 1% of total value of the materials as EMD.
- ii. The tenderer should enclose two separate Demand Drafts in the tender form towards cost of Tender papers & EMD. The Demand draft should be payable in favour of Aska Cooperative Sugar Industries Ltd and payable at Aska. Tender which is not accompanied with the cost of tender paper & EMD will not be considered as a valid tender. The EMD will be refunded without interest to the unsuccessful bidder after completion of the tender process. The EMD deposited by the successful tenderer will stand converted to Security deposit which will be refunded without interest after supply of materials.
- iii. There are two parts of these sealed Tenders Viz. Technical & Financial. The suppliers are required to duly fill up all the two parts of documents and place them in two separate sealed envelopes which should be superscribed as "TENDER FOR" TECHNICAL DOCUMENTS" & "TENDER FOR FINANCIAL DOCUMENTS". The two inner envelopes should be signed & kept in another outer sealed envelope and addressed to the Managing Director, Aska Co-operative Sugar Industries Ltd, Nuagam,

Aska-761111. The outer envelope must show the address & mobile phone no. of the suppliers and should be superscribed as "Tender for Supply of _____".

- iv. The Sealed quotations should reach the Aska Cooperative Sugar Industries Ltd., Aska through registered post/ speed post/courier till 05:00 PM of 20/11/2021 and the same will be opened at 11:30AM of 22/11/2021 in presence of the tenderers or their authorized representatives. No tender will be accepted beyond the stipulated date & time.
- v. The sealed tender must show the name of the Tenderer, address & should be superscribed on the envelope for supply of materials.
- vi. The offer sent through e.mail will not be accepted.
- vii. The documents should be accompanied with the GSTIN
- viii. *Interested tenderers are requested to furnish the rate on FOR Aska (factory site) including GST and other charges.*
- ix. If the size of the materials found less/short/any materials rejected then the same will be replaced by you free of cost/risk.
- x. The quantity of the material is tentative & can be increased or decreased
