SHORT TENDER CALL NOTICE

No.(Mktg.) 1599 Date: 31 / 12 / 2021

The Aska Cooperative Sugar Industries Ltd., Po.Nuagam (Aska) in Ganjam District of Odisha State invites sealed tenders from the intending Industrial users/distilleries/traders having legal authority to purchase molasses & registered under VAT/CST/GST Act for sale of **1000MT of good quality molasses of 2020-21** sugar cane crushing season production and stored in steel tank. The bidder is to quote rate of molasses per MT on Ex. factory basis. Taxes & duties, Transportation cost, lifting cost etc. as applicable at the time of lifting will be borne by the bidder/purchase.

1. Every tender should be accompanied with a **demand draft of Rs. 5.00 Lakh/- (five lakhs)** only as earnest money in favour of the **Aska Coop. Sugar Industries Ltd., Payable on any Nationalized Bank at Aska**. The tenderers should submit the required certificates as mentioned in the Tender Call Notice with the tender paper.
2. The said earnest money of successful bidders shall be converted to security deposit automatically which shall be retained by the Management as security for satisfactory execution and completion of lifting.
3. The earnest money deposited by un-successful bidder will be refunded after finalization of tender with out interest.
4. The security deposit shall be refunded to the successful bidder without interest after satisfactory completion of lifting of the entire allotted stock.
5. The bidder has to submit tender in the prescribed format enclosed for a **minimum quantity of 500 MT** of molasses
6. Tender paper may be down loaded from the website of ACSI Ltd., www.askasugar.com and the cost of tender paper RS 2000/- need be paid through Demand Draft in favour of Aska Cooperative Sugar Industries Ltd. Payable at Aska.
7. No correction and over writing in the tender paper shall be entertained.
8. The successful bidder should deposit the duty, taxes and value of molasses for the quantity before lifting the stock.
9. The tenderers or their authorized representative may remain present at the time of opening of the sealed tenders.
10. The tenders in sealed packet shall be received by the Aska Cooperative Sugar Industries Ltd. through Registered Post /Speed Post/ Courier Service only till **5:00 PM of 07/01/2022**. Technical Bid & financial bid will be opened at **11.30 AM of 08/01/2022**. There shall have two phase evaluation of Tender (a) **Technical Bid** & (b) **Financial Bid**. Tender for Technical bid with required document should be sent in a sealed cover super scribing "**Technical Bid**". The rate of MOLASSES / **Financial bid** should be placed in another separate sealed cover super scribing "**Financial Bid**" for PURCHASE OF MOLASSES. Both sealed covers should be placed in another Bigger Sealed cover subscribing "**TENDER FOR PURCHASE OF MOLASSES**".

11. The following documents shall be accompanied with the Technical Bid:

- i) Photocopy of the Income Tax Return of the tenderer for last 2 year i.e 2019-20 & 2020-21.
- ii) Photocopy of the MOLASSES Trading\Storage\Manufacturing license
- iii) Photocopy of the GST Registration Number
- iv) The Tender form cost Rs.2000/- (two hundred) only in shape of Bank Draft
- v) The EMD of Rs.5,00,000/-(Rupees five lakhs) refundable without interest only in shape of Bank Draft drawn in favour of the Aska Cooperative Sugar Industries Ltd., on any nationalized bank, Payable at Aska.


12. The allowed quantity of molasses shall be lifted within 15 days positively form the date of issue of sale order failing which the EMD/security amount deposited with the Industry will be forfeited.

13. It is responsibility of the successful bidders to obtain necessary permission from the Excise Commissioner, Odisha, Cuttack to lift molasses form the Aska Coop. Sugar Industries Ltd., Aska in time.

14. Failure to lift the molasses will bind the purchaser to make good the loss to the Industry.


15. The tender paper should also be accompanied with an affidavit of bidders to the effect that he/she will abide by the terms set out herein.






