The Aska Cooperative Sugar Industries Ltd., Aska, Ganjam, Odisha invites sealed Quotations from reputed Manufacturers having valid GSTIN for supply of 200ML Glass bottles to use in Country Liquor bottling units for the year 2022-23 (*Period from 01.05.2022 to 31.03.2023*)

**TERMS & CONDITIONS**

- I. The quantity may vary depending on the requirement of country spirit bottles by the Odisha State Beverages Corporation Ltd., Bhubaneswar, Odisha.
- II. Documents in prescribed form may be downloaded from the Industry website [www.askasugar.com](http://www.askasugar.com). The cost of tender paper is ₹500/- (Rupees five hundred) only which is non refundable & deposit in shape of demand draft in favour of Aska Coop. Sugar Industries Ltd, Payable at Aska failing which the documents shall be considered as invalid.
- III. There are two parts of this sealed quotations viz. Technical & Financial. The Manufacturers are required to duly fill up all the two parts of document and place them in two separate sealed envelopes which should be superscribed as "**TECHNICAL DOCUMENTS**" & "**FINANCIAL DOCUMENTS**". The two inner envelopes should be signed & kept in another big size outer sealed envelope and addressed to the Managing Director, Aska Cooperative Sugar Industries Ltd., Nuagam, Aska-761111. The outer envelope must show the address of the Manufacturers and should be superscribed as "**QUOTATION FOR 200ML GLASS BOTTLES**"

- IV. The Manufacturer has to deposit an amount of ₹5,00,000/- (Rupees five lakh) only as EMD (in shape of DD). The EMD amount will be converted as security deposit in case of successful bidder & refunded to the unsuccessful bidder after completion of the tender process without interest. The existing supplier does not required to deposit EMD but a letter should be attached in the technical bid stating that the SD amount with ACSI Ltd.
- V. The Sealed Quotations should reach the Aska Cooperative Sugar Industries Ltd., Aska through Speed Post/Registered Post/Courier before 05:00 PM of 05/05/2022. The documents will not be accepted beyond the stipulated date & time and the same will be opened in presence of the quotationers and/or their authorized representatives on 11:30AM of 06/05/2022.
- VI. *The following documents/photo copies shall be accompanied with Technical Bid otherwise, the tender paper will be rejected.*
- Registration certificate of Company/Firms etc.
  - Photocopy of the Income Tax Return for the financial Year 2019-20 & 2020-21.
  - Goods & Service Tax Registration Certificate with monthly return (*last 1 month*).
  - The Manufacturers should supply their company profile.
  - The Manufacturers should submit the photo copies of the orders they received from their customers to prove their ability to supply.
  - All Manufacturers will supply sample at the time of opening of the technical bid except the current supplier.
  - Demand draft of ₹500/-
  - Authorization certificate of the representatives.
  - Letter of EMD
- VII. The successful Manufacturer has to give an undertaking that they will supply the materials as per the requirement order sent by the Aska Cooperative Sugar Industries Ltd., Aska.
- VIII. The materials should be despatched through truck only.
- IX. The prices will remain firm during the entire specified period of supply. But, if any change in taxes and duties of the Government in the middle of the period, the rate will be changed accordingly. The revised Purchase order will be issued accordingly.
- X. The successful Manufacturers have to execute an agreement with the Industry.
- XI. Any violation of the contract due to which the Aska Cooperative Sugar Industries Ltd., Aska will incur financial loss will attract serious action against the successful Manufacturers even to the recovery of incurred loss amount.
- XII. No dealers/suppliers/C&F Agent /Commission Agent etc are allowed to participate in the tender. Their tender will be rejected without opening.
