

TERMS & CONDITIONS:

Sugar Industries Ltd www.askasugar.com. **The cost of quotation paper is `590/- (Rupees five hundred ninety) only which is not refundable. The quotationer should deposit 1% of total cost of the materials as EMD.**
- ii. The quotationer should enclose two separate Demand Drafts in the quotation form towards cost of quotation papers & EMD. The Demand draft should be payable in favor of Aska Cooperative Sugar Industries Ltd and payable at Aska.
