3-Belt will be utilized for production of 96 bottles per minute each.

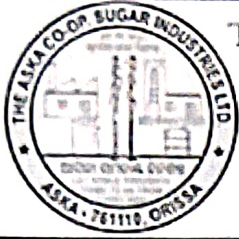
2-Belt will be utilized for production of 120 bottles per minute each.

The Aska Cooperative Sugar Industries Ltd., at Nuagam, Aska in Ganjam District of Odisha State invites sealed tenders from experienced and reputed contractors for Country Liquor Bottling of 40° UP in 200 ML Glass Bottles from its 5-Belt Semi-automatic and 1 no. of Automatic Bottling unit for the period 01.06.2026 to 31.03.2027.

A. THE TENDER PAPER SHOULD BE ACCOMPANIED WITH THE FOLLOWING TECHNICAL BIDS.

- I) The tenderer should submit his company profile.
- II) Experience Certificate from the principal employer in Liquor Bottling Unit for a period of minimum 3(Three) years for carrying out the job mentioned at SIno. B. In case of any doubt regarding genuineness of the certificate the same may be referred to the concerned authority for verification.
- III) Minimum 3 (Three) year experience in handling of Fragile materials.
- IV) The tenderer will submit the EPF& ESIC establishment code Number and ECR of both EPF & ESIC with challan copy of February – 2026 for minimum 400 workers.
- V) Photo Copy of the PAN card and GST Registration number.
- VI) Income Tax return for the financial years 2022-23, 2023-24 & 2024-25.
- VII) Latest GST 3 B return copies.
- VIII) The tenderer will submit the Labour Licence under contract Labour (Regulation & Abolition) Act 1970 which had been issued in his favour for undertaking the job shown in the experience certificate of the company duly signed by the statutory authority.
- IX) Demand Draft for Rs. 10,00,000/- (Rupees ten lakhs) only each for semi-auto & automatic bottling units in favour of the Aska Cooperative Sugar Industries Ltd, Aska payable at State Bank of India, Aska /or any nationalized bank at Aska towards EMD. The existing tenderer does not require to deposit EMD but a letter should be attached in the technical bid stating that the SD amount with ACSI Ltd.
- X) Tender paper may be downloaded from the website of ACSI Ltd., www.askasugar.com and the cost of tender paper Rs.11800/- (rupees eleven thousand eight hundred) only including tax need be paid through Demand Draft only in favour of "The Aska Cooperative Sugar Industries Ltd.," payable at Aska.
- XI) The bidder must have a turn over at least Rs. 4.00 Core in each financial year i.e. 2022-23, 2023-24 & 2024-25. (CA certificate for turnover proof to be submitted).
- XII) Bidders should not have been blacklisted or debarred by any Central or State Govt. / Organization / PSU / Institutions / Corporations etc. As on last date of selection of bid. In this connection, the bidder should submit a notarized affidavit stamp paper of Rs. 100 to this effect that it has never been blacklisted by any organization.

B. THE JOB INCLUDES:

- I) Collection of bottles, packing materials and other consumables from the stockyard of General store.
- II) Brushing cleaning & washing of bottles in washing machine.
- III) Filling country liquor in bottles & Sealing of Bottles with cap.
- IV) Printing of Batch No. & date on the Labels & its fixing on bottles. Fixing of EAL on each bottle.
- V) Packing of bottles in cartoons.
- VI) Stacking the cartoons properly.
- VII) Minor maintenance of the Unit.

C. RESPONSIBILITY OF THE CONTRACTOR:

- I) The contractor has to produce 5,00,000 bottles of country liquor per day which may increase or decrease depending up on the demand and supply situation and instruction of Excise department and Odisha State Beverage Corporation time to time.
- II) The contractor shall be held responsible for maintenance of hygienic condition of the unit. The finished product should be free from foreign materials.
- III) The contractor shall execute an agreement with The Aska Cooperative Sugar Industries Ltd. for the contract period as per terms & conditions of the Agreement to be entered with.
- IV) Maintenance of industrial peace.
- V) The bottling contractor is fully responsibility for Accidental death / Permanent disability / partial disability during working in Bottling plant.
- VI) The contractor will ensure the Insurance coverage by taking a WCP of his workmen as mandated by the Workmen's Compensation Act, 1923. .
- VII) The contractor will comply all the statutory laws like Bonus act, Payment of gratuity and other law of state / union govt act which protect the social security of the workmen.

D. The tender shall be received by the Aska Co-operative Sugar Industries Ltd. Aska through Registered post / Speed Post only in sealed packet till 5:00 PM of 20/05/2026. There are two parts of this Tender Document namely: **Technical Bid and Financial Bid**. The tender is required to fill up all the two parts of tender document and place them in two separate sealed envelopes which should be super scribed as **"Tender For Bottling in Both Semi-automatic & Automatic Bottling unitTechnical Bid"** And **Tender For Bottling in Both Semi-automatic & Automatic Bottling unit- Financial Bid"** The two inner envelopes should be placed in another outer sealed envelope and addressed to the Managing Director, Aska Co-operative Sugar Industries Ltd. Nuagam, Aska. The outer envelope must show the name of the tenderer, address and should be superscribed as **"Tender For Bottling in Both Semi-automatic & Automatic Bottling unitfor the period 01.06.2026 to 31.03.2027** at the top of the envelope

E. The TECHNICAL BIDS of the tenderers will be opened at 10:30AM on dt. 21/05/2026 in the office of the ACSIL in presence of the tenderer or their authorized representative. If after enquiry it is found that any document filed by the tenderer is false the EMD will be forfeited and the contract will be terminated if it is assigned.

- F. The FINANCIAL BIDS of the tenderers whose technical bid got qualified will be opened in the same day. Award of contract may be made on same day or on a later stage after proper verification of rate and other credentials of the successful Bidder.
- G. EMD deposited vide SI No. A(ix) will be refunded to unsuccessful bidder at a later stage without interest and the successful bidder will be retained towards Security Deposit for the contract period and bears no interest.
- H. In the event of non-submission of any document mentioned at 'A' with the tender paper, it will be rejected during scrutiny itself.
- I. The tenders will mandatorily quote for bottling work of both semi & Automatic Bottling unit and produce all the enclosures in original with seal at the time of opening the tender failing which the tender will be rejected.
- J. The contractor shall make payment the monthly wages to his workers engaged in the unit as per their category within 3 days of completion of the month as per the calendar year & following the minimum wages Act of Govt. Of Odisha from time to time and shall produce the bottling bill alongwith wage payment sheets within 7 days from the date of wage payment by the contractor to the engaged workers. EPF ,ESI , GST payment and return compliance to be complied by the bidder contractor within prescribed time frame laid down by respective statutory bodies/authorities and the proof of that particular month will be submitted to ACSILtd for verification along with the bottling bill of subsequent month .
- K. The bidder must have a positive net worth based on the latest financial year i.e. 2024-25.
- L. Bidders should not have been blacklisted or debarred by any Central or State Govt. / Organization / PSU / Institutions / Corporations etc. As on last date of selection of bid. In this connection, the bidder should submit a notarized affidavit stamp paper of Rs. 100 to this effect that it has never been blacklisted by any organization.
- M. If more than one agency quote the financial bid same and found L1, then the agency having highest annual turnover & having more experience will be considered.
- N. The committee reserves the right to accept any tender or reject any or all tenders without assigning any reason thereof.
- O. Conditional bid/quotation will not be allowed.
- P. Any violation of the contract for which ACSIL will incur loss serious action will be taken on contractor as per law to recover the loss and EMD will be forfeited.
- Q. Those contractors have any dispute with ACSIL in the said work will not be allowed participate in the tender process.
- R. Any further addition / corrigendum will be published only in website www.askasugar.com .
- S. Dispute (if any) will be reoffered to the Register of Co-operative Societies, Odisha, Bhubaneswar jurisdiction only.
- T. If required the work may be extended basing upon requirement of Industry and mutual agreement between ACSILtd & the successful bidder.
