Tender for Technical bid with required document should be sent in a sealed cover super scribing "Technical Bid" *FOR PURCHASE OF Semi Processed Sugar* should be placed in another separate sealed cover super scribing "Financial Bid" **Semi Processed Sugar** Both sealed covers should be placed in another Bigger sealed cover super scribing, "**TENDER FOR PURCHASE OF Semi Processed Sugar**."


