Seale tenders are invited from contractor / organization having required license and interested in taking up the following works date- 01.05.2026 to 31.03.2027. with the condition that the tender will be valid till the date of introduction of the fork lifting system in ACSI Ltd. Tender for lifting system will be floated in future.

SPECIFICATION OF WORK

Loading of 1000 nos. of Liquor Box on the Truck from Automatic Bottling / Semiautomatic Bottling plant. Each box containing 25 nos of Liquor Bottle.

The tenders in sealed packet shall be received by the Aska Co-operative Sugar Industries Ltd., through Registered Post / Speed Post only till 05:00 PM of 28 / 04 / 2026. The Tender will be opened at 12.30 PM. On 29 / 04 / 2026. There shall two phase evaluation of Tender (a) Technical Bid & (b) Financial Bid. The tender for Technical bid with required document should be sent in a sealed cover super scribing "Technical Bid" another separate sealed cover super scribing "Financial Bid" in the prescribed form and both sealed covers should be placed in another bigger sealed cover super scribing, "TENDER FOR LIQUOR BOX LOADING ON THE VEHICLE.

Tender paper may be down loaded from the website of ACSI Ltd., www.askasugar.com and the cost of tender paper RS.590-including GST (Rupees Five Hundred Ninety) only need be paid through Demand Draft in favour of "The Aska Co-operative Sugar Industries Ltd." Payable at Aska.

The tender should accompany with bank draft Rs.1,00,000/- (Rupees One Lakh) only towards Earnest money Deposited through Demand Draft in favour of "The Aska Co-operative Sugar Industries Ltd." Payable at Aska. The existing contractor does not required to submit Demand Draft of EMD but a letter should be attached in the technical bid stating that the SD amount with ACSI Ltd.

Financial Bid:

The rate per 1000 Liquor BOX loading on the truck should be mentioned in the prescribed format (inclusive of GST).

Terms & Conditions:

1. The Contractor should keep his men available from 6 AM to 10 PM as per requirement of the works and following the timings prescribed by the industry.
2. The Contractor should arrange to deposit the P.F. dues of his labourers engaged for the work with the P.F. Authorities according to the P.F. Rules & submit the ECR chalan for release of payment.
3. Security Deposit @5% of bill and Income Tax as per rule will be deducted from the gross amount of the bill. The Contractor will be paid his bill once in a month i.e. after end of month . The security deposit may be released after successful completion of the work assigned. The security deposit shall not carry any interest, and no interest shall be paid on S.D deposited with us.
4. The contractor should maintain discipline among his own workers and their behaviours to our employees should be cordial always. The Worker should not report for stoppage or works at any stage and at any time by any sort of nuisance. In case they bring any loss by their action as above, the entire loss shall be recovered from him.
5. The contractor shall arrange to ensure strict compliance to the provisions of the Labour Laws as required and shall submit a copy of Labour License along with tender paper.
6. The contractor must have valid labour license and ensure to submit insurance copy of labour on getting this work order.
7. The contractor shall not engage any person against whom criminal proceedings has been filed/pending in any court.
8. The Contractor has make insurance for the workmen engaged and he is fully responsible for any accident / injure / loss occurs to them during execution of above job.
9. Persons engaged in the job should not make unfair demand to the Driver of truck. If any complaint raises, the work order shall be cancelled.
10. The Committee reserves the right to cancel any or all tender at any stage without assigning any reason.

11. In case of any failure to abide by the conditions the money so deposited shall be forfeited without any reference or notice. The authority reserves the right to reject / cancel all or any tender at any stage without assigning any reason thereof.
