The Aska Cooperative Sugar Industries Ltd., Aska invites sealed Tender's from interested Manufacturer/Dealers/supplier having provisional GSTIN for **Supply, Fabrication, Erection & Commissioning of 30000 LTR Blending Vessel with Agitator Assembly and Recirculation pump with Flameproof Motor for producing of Country Liquor on Turnkey basis** as detailed at tender form along with specifications at annexure.-I

**TERMS & CONDITIONS:**

- i. The Tender forms are available by down loading from the website of the Aska Coop. Sugar Industries Ltd [www.askasugar.com](http://www.askasugar.com). The cost of tender paper (inclusive of GST) is 5900/- (Rupees five thousand nine hundred) only in shape of demand draft which is not refundable. The bidder should deposit 5% of total quoted cost of the materials as EMD in shape of demand draft. Both the demand draft should be favoring of "The Aska Cooperative Sugar Industries Limited" payable at Aska , Ganjam , Odisha .
- ii. The bidder should enclose two separate Demand Drafts in the tender form towards cost of tender papers & EMD. The Demand draft should be payable in favor of Aska Cooperative Sugar Industries Ltd and payable at Aska. Tender which is not accompanied with the cost of tender paper & EMD will not be considered as a valid tender. The EMD will be refunded without interest to the unsuccessful bidder after completion of the tender process. The EMD deposited by the successful tendered will stand converted to Performance Security deposit

which will be refunded without interest after one year from the date commissioning period.

- iii. There are two parts of these sealed Tendered Viz. Technical & Financial. The suppliers are required to duly fill up all the two parts of documents and place them in two separate sealed envelopes which should be super scribed as "TENDER FOR" TECHNICAL DOCUMENTS" & "TENDER FOR FINANCIAL DOCUMENTS". The two inner envelopes should be signed & kept in another outer sealed envelope and addressed to the Managing Director, Aska Co-operative Sugar Industries Ltd, Nuagam, Aska-761111. The outer envelope must show the address & mobile phone number of the suppliers and **should be super scribed as "Tender" for Supply, Fabrication, Erection & Commissioning of 30000 LTR Blending Vessel with Agitator Assembly and Recirculation pump with Flameproof Motor for producing of Country Liquor on Turnkey basis.**
- iv. - Vii. If the material so supplied found to be defects the supplier will be returned back the defective material at their own cost & risk. ACSIL will not liable for the payment of any defective material.
- ix. Rates are to be quoted separately for cost of material and erection & commissioning, but the selection will be out of L1 of total cost.

- xi. Conditional bid will not be accepted.
