The Technical & Financial Bid will be opened at 11.30 AM/PM on 24/12/2025. There shall be two phase evaluation of tender (a) Technical Bid (b) Financial Bid. The tender for technical bid with required documents should be send in sealed cover super scribing technical bid and another sealed super scribing finical bid in the prescribed form & both sealed covers should be placed in another a bigger sealed cover super scribing tender for **"Supply of labours of cleaning, shifting & removal of ash & bagasse"**.

**Scope of work:-**

**Supply of labourers for Boiler area cleaning, removal & shifting of Boiler ash from furnace to ash pit and Mill house Cane Carrier cleaning in each shift for season 2025-26.**

1. The contractor has to engage labourers for Cleaning of Boiler area, Removal & Shifting the Boiler Ash from both Boiler Furnace to boiler ash pit area & cane carrier cleaning under the supervision of Shift Engineer in each 3 shift/day of 8 hours.
2. The Contractor shall not engage labour below 18 years age & above 50 years.
3. The labourers can be engaged as and when required inside plant by A.E & Foreman.
4. The contractor should arrange loading, shifting and remove all garbage materials as per direction of Boiler Attendant failing which suitable penalty would be levied as per the direction of the Management.


**Terms & Conditions:-**

4. Income tax as per Government Rules will be deducted from the bill amount. EMD will be refunded after closure of the season.
5. Any law existing or likely to be enforced by government and if it requires any compliance, shall be lookout of the contractor only.
6. The contractor has to submit the list of the manpower details, Aadhaar proof of all labours duly attested by the contractor & insurance paper in the security office of the industry for issue of identity card for identification at factory gate.
7. The Authority also reserves the right to terminate / cancel the work order at any stage in case you fail to meet the above indicated conditions and EMD shall be forfeited.
8. Proportionate deduction will be made in case of less labour supply.
