SHORT TENDER CALL NOTICE

(For Removal, Loading, & Shifting of Boiler Ash)

The Aska Co-operative Sugar Industries Ltd., Aska invites sealed tenders from interested labour contractors/vendors having labour license for "**Removal ,Loading, & Shifting of Boiler Ash to suitable place within 2 km radius**" during the crushing season 2025-26 in its sugar plant.

The tenders in sealed packets should be reached to the Managing Director, Aska Co-operative Sugar Industries Ltd., Nuagam, Pin- 761111, Aska, Ganjam, Odisha, through registered post / speed post only till 5:00 PM of 23 / 12 /2025. The Technical & Financial Bid will be opened at 12 AM/PM on 24 / 12 /2025. There shall be two phase evaluation of tender (a) Technical Bid (b) Financial Bid. The tender for technical bid with required documents should be send in sealed cover super scribing technical bid and another sealed super scribing finical bid in the prescribed form & both sealed covers should be placed in a bigger sealed cover super scribing tender for "**Removal, Loading, & Shifting of Boiler Ash**".

Tender form may be downloaded from website of ACSI Ltd. www.askasugar.com and cost of tender form is Rs 590 /- (Rupees Five hundred ninety only) including GST need to be paid through demand draft in favour of Aska Co-operative Sugar Industries Ltd. payable at Aska.

The tender should be accompany bank draft of Rs 5,000 /- (Rupees Five thousand) only towards Earnest Money Deposit through Demand Draft in favour of "The Aska Co-operative Sugar Industries Ltd." payable at Aska.

The following documents shall be enclosed in Technical Bid.

1. Cost of Tender form Rs 590 /- (Rupees Five hundred ninety) only non-refundable in shape of Bank Draft in favour of Aska Co-operative Sugar Industries Ltd. on any Nationalized Bank, payable at Aska.
2. EMD of Rs 5,000 /- (Rupees Five Thousand) only in shape of Bank Draft in favour of Aska Co-operative Sugar Industries Ltd. on any Nationalized Bank, payable at Aska. Refundable to the tenderer without interest after successful completion of work. The EMD of unsuccessful Contractor will be returned back without interest.
3. Photocopy of the Vaild Labour License.
4. Photocopy of the EPF Registration.
5. Photocopy of the PAN Card.
6. Photocopy of the Driver license / Vaild RTO related documents of tractors.

Financial Bid:

1. Quoted price per loaded tractor.

Scope of Work:-

Engagement of tractors with drivers and required manpower for removal, loading, & Shifting of Boiler Ash and unloading the same in low laying area of Industry within 2km radius from Both Boilers for Season 2025-2026.

1. The accumulated boiler ash is to be removed from their respective site every day and there will have to be no surplus ash at their site.
2. During all crushing period Tractors are to be made available at site and ash is to be removed without fail in all the day.
3. Tenderer should furnish the details of ash removed (no. of Tractors) entered at the security gate register. Bills should be submitted duly certified by Security Officer at the time of producing bills for payment.
4. Before lifting the materials the tenderer shall note departure time of tractor & take a signature of Security guard at gate before the vehicles leaves the main gate.
5. Tenderer should ensure that sufficient Tractor & Manpower are available for removal of Boiler ash without affecting Mill production otherwise penalty would be charged.
6. The Contractor shall not engage labour below 18 years age & above 50 years.
7. The required tools and tackles for loading, unloading & consumable items are to be arranged by the contractor.
8. Tenderer should ensure that his authorized agent is available on the Boiler area to supervise the activities.

Terms & Conditions:-

1. No Advance payment will be made.
2. The contractor has to make insurance for the workmen engaged and he is fully responsible for any accident/injury/loss occurs to them during execution of above job.
3. The payment will be made monthly (basing on calendar month) only per full tractor load (cabin level) on total no. of loads removed as per the record.
4. The income tax as per Government Rules will be deducted from the bill amount.
5. The contractor has to give two numbers of passports photo of the Drivers / Aadhaar card/Labourers & Xerox copy insurance paper of the labourers to the security officer of the industry for issue of identity card for identification at factory gate.
6. Any law existing or likely to be enforced by government and if it requires any compliance, shall be lookout of the contractor only.
7. The Authority reserves the right to terminate / cancel the work orders at any stage in case you fail to meet the above indicated conditions and EMD shall be forfeited.
8. The employees of A.C.S.I.Ltd can't participate in the tender.
