### TERMS & CONDITIONS

- I. The quantity may vary depending on the requirement of country liquor bottles by the Odisha State Beverages Corporation Ltd., Bhubaneswar, Odisha.
- II. Documents in prescribed form may be downloaded from the Industry website [www.askasugar.com](http://www.askasugar.com). The cost of tenders paper is **Rs. ₹590/- (Rupees five hundred ninety)** only including tax which is non refundable & deposit in shape of demand draft only in favour of Aska Coop. Sugar Industries Ltd, Payable at Aska failing which the documents shall be considered as invalid.
- III. There are two parts of this sealed tenders viz. Technical & Financial. The Manufacturers / Authorized Dealers are required to duly fill up all the two parts of document and place them in two separate sealed envelopes which should be superscribed as "**TECHNICAL DOCUMENTS**" & "**FINANCIAL DOCUMENTS**". The two inner envelopes should be signed & kept in another big size outer sealed envelope and addressed to the Managing Director, Aska Cooperative Sugar Industries Ltd., Nuagam, Aska-761111. The outer envelope must show the address of the Manufacturers and should be superscribed as "**TENDER FOR BOPP SELF ADHESIVE TAPE**"

- IV. The Sealed Tenders should reach the Aska Cooperative Sugar Industries Ltd., Aska through Speed Post/Registered Post before 5 PM of 17/04/2025. The documents will not be accepted beyond the stipulated date & time and the same will be opened in presence of the quotationers and/or their authorized representatives on **12.00 noon** of 18/04/2025.
- V. **The following documents/photo copies duly self attested with seal shall be accompanied with Technical Bid otherwise, the tender paper will be rejected.**
- a. Registration certificate of Company/Firms etc.
  - b. Photocopy of the Income Tax Return for the financial Year 2022-23& 2023-24. & photo copy of PAN.
  - c. Turnover should be minimum of 40 Lakh per annum(CA Certified copy to be submitted )
  - d. Goods &Service Tax Registration Certificate along with latest copy of return.
  - e. The Manufacturers/Suppliers should submit their company profile and undertaking for not having court cases as mentioned in clause no- XVI and XVII
  - f. The Manufacturers/Suppliers have twoyears experience in supplying to any bottling company. Photo copies of the orders to prove their ability to supply.
  - g. All Manufacturers/Suppliers will supply sample at the time of opening of the technical bid except the current supplier.
  - h. Demand draft of ₹590/- including tax and EMD in shape of DD of Rs 50000/- in favour of The Aska Cooperative Sugar Industries Ltd payable at Aska .
  - i. Authorization certificate along with attested copy of I.D proof of the representatives.
- VI. The Manufacturer(s)//Suppliers have to deposit an amount of **Rs.50,000/- (Rupees fifty thousand)** only as EMD (in shape of DD) infavour of The Aska Cooperative Sugar Industries Ltd payable at Aska. The EMD amount will be converted as security deposit in case of successful bidder & refunded to the unsuccessful bidder after completion of the tender process without interest. The existing supplier does not require to deposit EMD but a letter should be attached in the technical bid stating that the SD amount with ACSI Ltd
- VII. The successful Manufacturers//Suppliers have to give an undertaking that they will supply the material as per the requirement order sent by the Aska Cooperative Sugar Industries Ltd., Aska.
- VIII. The prices will remain firm during the entire specified period of supply. But, if any change in taxes and duties of the Government in the middle of the period, the rate will be changed & revised Purchase order will be issued accordingly.
- IX. TDS will be deducted as per of rule by A.C.S.I.Ltd.,Aska.
- X. Purchase Order will be issued only after execution of agreement with the Industry.
- XI. Any conditional tender will not be allowed.
- XII. Any violation of the contract due to which the Aska Cooperative Sugar Industries Ltd., Aska will incur financial loss will attract serious action against the successful

Manufacturers/ /Suppliers even to the recovery of incurred loss amount. EMD will be forfeited,

- XIII. For any dispute, the Registrar of Co-operative Societies, Odisha Jurisdiction only.
- XIV. The Committee of A.C.S.I.Ltd., reserves the right to split the quantity on L1 rate.
- XV. Goods/material will be procured exclusively on credit basis. The payment will be processed after having quality certified of the concern material within a period of 45 days to 60 days.
- XVI. The Manufacturer firm having any disputes/cases in any court / Authority in previous period or any other firm / joint venture firms presently represented / owned by any directors / partners / owners who was earlier having partners ship / ownership with the firm having disputes / cases as mentioned in previous period are not allowed to participate in the Tender Call process.

To the effect of clause above, the interested bidder should submit an undertaking that " the manufacturer firm and its present directors, partners/ Owners have not associated directly / indirectly with any other firm and not having a court case / dispute cases in any Court / Authority in past days.
