TENDER CALL NOTICE

The Aska Co-operative Sugar Industries Ltd. Aska intends to procure Extra Neutral Alcohol (ENA) as per the specification and requirement indicated below for production of Country Liquor for the period from 01-06-25 to 31-03-26 interested persons/firms such as distilleries / facilitators /Suppliers.

01. The quantity may vary depending on the requirement by the Odisha State Beverages Corporation Ltd.
02. Old and rusted containers should not be used for transportation of ENA. The tanker should have valid calibration certificate with deep rod .
03. Each consignment will be checked as per the IS: 6613 : 2002 and unloaded if found suitable only.
04. Interested suppliers / manufacturers may submit their Tender (F.O.R Aska) in sealed cover super scribing " TENDER FOR SUPPLY OF Extra Neutral Alcohol (ENA)for the period from 01-06-25 to 31-03-26".
05. No Tender will be accepted by email, courier .
06. The F.O.R. rate shall include cost of Extra Neutral Alcohol (ENA) including all Taxes & Duties of State/Center/Union Territory like GST / CST /VAT/ Export fee of concerned State, Import Fee & transport fee per Bulk litre applicable for Odisha State as per the State Excise Policy 2024-25 and upcoming 2025-26 and freight charges & transit insurance etc. excluding TCS. TDS will be deducted by ACSIL as per rule.
07. The Tender in sealed packet shall be received by the Aska Co-operative Sugar Industries Ltd. through **Registered Post / Speed Post** only till **5:00 PM of 15 / 05 /2025**. No Tender will be accepted other than Registered Post / Speed Post. The Tender will be opened at **11:30 AM of 16 / 05 / 2025**. There shall have two phase evaluation of Tender(a) Technical Bid & (b) Financial Bid. Tender for technical bid with required document should be sent in a sealed cover superscribing " Technical Bid " The rate of ENA / Financial bid should be placed in another separate sealed cover superscribing "Financial Bid " for supply of ENA. Both sealed covers should be placed in another Bigger Sealed cover superscribing Tender for Supply of ENA to ACSIL for the period from 01-06-25 to 31-03-26.
08. The following documents shall be accompanied with the Tender.

Technical Bid

- a) Consent letter of the distillery along with distillery license and 2 years production data of ENA from whom the Extra Neutral Alcohol (ENA) will be supplied should be enclosed in case of facilitators /Suppliers
- b) The bidders should have last 2 years of experience in supplying ENA to liquor bottling plant to Govt /Co-operation /PSU or any other Bottling Plant.
- c) Photocopy of the Income Tax Return of the tenderer for last 3 financialyears.i.e.2021-22 , 2022-23 & 2023-24.

- d) Photocopy of the GST Registration / VAT Certificate and latest GST return 3B/ VAT return (As per applicability)
- e) The Tender form cost Rs. 5900/- (Five Thousand Nine Hundred) only including GST in shape of Demand Draft drawn in favour of the Aska Co-operative Sugar Industries Ltd. on any Nationalized bank, payable at Aska.
- f) The EMD of Rs.15,00,000/- (Rupees Fifteen Lakhs) refundable without interest only in shape of Demand Draft drawn in favour of the Aska Co-operative Sugar Industries Ltd. on any Nationalized bank, payable at Aska. The said EMD of the successful bidder will be retained towards Security Deposit for the contract period and bears no interest. The existing supplier need not to submit in shape of Demand Draft but a letter should be attached in the technical bid stating that the SD amount is already retained with ACSI Ltd however differential amount of EMD should be submitted in the same manner as mentioned above vide Demand draft.
- g) The suppliers should submit the Registration Certificate under Company Act any other act there off by competent authority.
- h) The interested bidder should submit an undertaking that they will comply to all the eligibility norms during the period of supply to ACSI Ltd as per the requirement of State Excise, Government of Odisha.
- i) The interested bidder all so submit an undertaking that they will not interrupt the supply for which ACSI Ltd faces dry in Production situation due to shortage of ENA and not having any court cases as mentioned in clause no- 21 & 22.
- j) Preference will be given to the suppliers/ manufacturers who can supply from Odisha Distilleries .
- k) The bidders should have a turn over not less than INR 10 crores only (CA certified copy to be produced)
- l) Conditional Bid/rate will not be allowed.
- m) All the documents should be self-attested with the seal.

FINANCIAL BID

- (A) Rate per BL of ENA (FOR Aska) to be quoted in the **prescribed FINANCIAL BID** format.
09. The Tender paper may be down loaded from the website of ACSI ltd. www.askasugar.com and the cost of Tender paper Rs 5900/- (Five Thousand Nine Hundred) only including GST non refundable need to be paid through Demand Draft in favour of The Aska Co-operative Sugar Industries Ltd. on any nationalized bank. Payable at Aska.
 10. The Tender without cost of tender paper will be rejected.
 11. The successful bidder has to execute an Agreement immediately with the Aska Co-operative Sugar Industries Ltd. Aska after finalizing the tender for the deal and also submit an affidavit a firming the causes mention in 8 (g) ,8 (h) above.
 12. The price so finalized will remain firm for the entire specified period of supply. But, if any change in taxes, duties & Excise Policy of the Government middle of the period, the rate will be changed accordingly. The revised Purchased Order will be issued accordingly.
 13. The Committee reserves the right to split the quantity of L1 rate among multiple bidders.
 14. The payment will be made to the supplier after receipt of goods and the goods will laboratory tested by Aska CSI Ltd. at factory location.
 15. Any violation of the contract due to which the Aska Co-operative Sugar Industries Ltd. Aska incurs financial loss will attract serious action against the supplier as per law. Also the EMD of the successful bidder shall be forfeited.
 16. The Suppliers / Manufacturers who have been black-listed by this factory cannot participate for supply of ENA Tender call notices.
 17. Conditional bid / Tender will not be allowed.
 18. The Committee reserves the right to accept or cancel any or all Tender at any stage without assigning any reason thereof.
 19. Any future addition/corrigendum will be published only in website www.askasugar.com

20. If required the supply period may be extended upon requirement of the Industry and basing upon mutual agreement between ACSI Ltd and the Successful bidders .
- 21 The Interested bidder having any disputes/cases in any court / Authority in previous period or any other firm / joint venture firms presently represented / owned by any directors / partners / owners who was earlier having partners ship / ownership with the firm having disputes / cases as mentioned in previous period are not allowed to participate in the Tender Call process.
- 22 To the effect of clause above, the interested bidder should submit an undertaking that " the manufacturer firm and its present directors, partners/ Owners have not associated directly / indirectly with any other firm and not having a court case / dispute cases in any Court / Authority in past days.
- 23 Goods/material will be procured exclusively on credit basis. The payment will be processed after having quality certified of the concern material within a period of 45 days to 60 days.
