**DETAILED TERMS & CONDITIONS FOR TRANSPORTATION OF COUNTRY
LIQUOR BOTTLES FOR THE YEAR 2026-2027.**

A. GENERAL INFORMATION

01. Sealed tenders in the prescribed form are invited from intending firms / individuals etc having valid transport license under Carriage by Road Rules - 2011 issued recently by the competent authority for undertaking transportation of Country Liquor from the premises of Aska Co-operative Sugar Industries Ltd, Aska to different depots of Odisha State Beverages Corporation Ltd.
02. The tender papers giving details regarding terms and conditions earnest money deposit etc. can be obtained by down loading from the website of the Aska Co-operative. Sugar Industries Ltd. www.askasugar.com. The cost of tender paper is Rs. 5,900/- (Rupees Five Thousand Nine Hundred) only. The amount is not refundable. The tender should enclose a Bank Demand Draft along with the tender form towards cost of Tender papers. The bank Demand Draft should be payable in favour of Aska Co-operative Sugar Industries Ltd and payable at Aska. Tender which is not accompanied with the cost of tender paper will not be considered as a valid tender.
03. The tender shall be received by the Aska Co-operative Sugar Industries Ltd. Aska through Registered post / Speed Post only in sealed packet till **5:00 PM of 28/04/2026**. The tender will be opened on **29/04/2026 at 2:30 PM** in the office of the Aska Co-operative Sugar Industries Ltd. in presence of the tenderers or their authorized agents.
04. There are two parts of this Tender Document namely: **Technical Bid and Financial Bid**. The tender is required to fill up all the two parts of tender document and place them in two separate sealed envelopes which should be super scribed as **"Tender For Transporting Country Liquor Bottles - Technical Bid" And Tender For Transporting Country Liquor Bottles - Financial Bid"** The two inner envelopes should be placed in another outer sealed envelope and addressed to the Managing Director, Aska Co-operative Sugar Industries Ltd. Nuagam, Aska. The outer envelope must show the name of the tenderer, address and should be superscribed as **" Tender For Transporting Country Liquor Bottles For 2026-2027 for the depot namely _____"** at the top of the envelope.
05. The tenderer has to quote the rate of transportation charges including toll TAX & other incidental charges.
06. The tender received beyond the stipulated date time and requisite documents shall be liable for rejection by the committee.
07. The tenderer shall furnish an affidavit to the effect that he is not involved in any criminal activity or black listed by any office / organizations.
08. The successful tenderer shall be required to lift Country Liquor from Aska Co-operative Sugar Industries and transport the same stock to different depots of Odisha State Beverages Corporation Ltd. located at Khorda, Nirgundi, Balasore & Chandikhhol as per instructions to be issued by the Aska Co-operative Sugar Industries Ltd from time to time.

09. The Tender paper should be filled properly and legibly without any correction/overwriting & duly signed as a token of acceptance of the terms & conditions. The rate should be written both in figures and words in the tender form. The rate quoted should be final and the tenderer shall not be allowed to change it under any circumstances.
10. E bank Guarente in favour of Managing Director, The Aska Cooperative Sugar Industries ltd., Aska, required to be submitted separately depot wise as bellow: Khordha - Rs.1500000/-, Nirgundi - Rs. 1500000/-, Balesore- Rs.1000000/- & Chandhikholo - Rs. 1000000/-.
11. (a) Required amount of Earnest money as per the table below only in shape of Demand draft drawn in favour of the Aska Co-operative Sugar Industries Ltd. Aska payable at Aska Should be attached with tender paper. No tenderer shall be allowed to withdraw its tender /earnest money deposit until the tender is finalized. The EMD of unsuccessful tenderers shall be refunded to them without interest after finalization of the tender process. In case the successful tenderer refuses to do the transporting work after acceptance of its tender, earnest money deposited by it will be liable for forfeiture. Details of EMD to be deposited and cost of tender paper depot wise is given below. The number of Trips/Trucks may vary depending on the requirement of OSBC Ltd.
