The party shall pay tax as applicable on the approved rates. TCS will be collected by ACSIL as per rule (if applicable).

The tender should accompany with bank draft Rs.10,000/- (Ten Thousand only) for towards EMD drawn in favour of Aska Co-operative Sugar Industries Ltd., payable at Aska.

Earnest money deposited by the successful tenderer shall stand converted to security deposit, which will be refunded after successful completion of contract period without interest.

On 29 /10/2024. There shall be have two phase evaluation of Tender (a) Technical Bid & (b) Financial Bid. Tender for Technical bid with required document should be sent in a sealed cover super scribing "Technical Bid" Purchase of EAL (Excise Adhesive Level) garbage & "Financial Bid" should be placed in another separate sealed cover super scribing "Financial Bid" for Purchase of EAL (Excise Adhesive Level) garbage. Both sealed covers should be placed in another Bigger sealed cover super scribing, "TENDER FOR PURCHASE OF EAL EXCISE ADHESIVE LEVEL GARBAGE MATERIALS.

The tenderer is responsible for loading of material at his own cost with vehicle & labourers. He will submit the list of labourer to Security Officer of ACSI Ltd. Aska.
