TENDER CALL NOTICE
(For Removal of Filter Cake – Press mud)

The Aska Co-operative Sugar Industries Ltd., Aska hereinafter called "The Industry" invites sealed tenders from interested contractors/organizations having required license for removal of Filter Cake (Press Mud) to be produced from its sugar plant during the crushing season 2023-24.

The tenders in sealed packet shall be received by the Aska Cooperative Sugar Industries Ltd. through Registered Post /Speed Post only, till 05:00 PM of 26 /12/2023. The Technical Bid & Financial Bid will be opened at 3 :30 PM on 27/12/2023. There shall be two phase evaluation of Tender (a) Technical Bid & (b) Financial Bid. The tender for Technical bid with required document should be sent in a sealed cover super scribing "Technical Bid" another separate sealed cover super scribing "Financial Bid" in the prescribed form. And both sealed covers should be placed in another Bigger sealed cover super scribing, "**TENDER FOR REMOVAL; OF FILTER CAKE** .

Tender paper may be down loaded from the website of ACSI Ltd., www.askasugar.com and the cost of tender paper of Rs.590/- (Rupees Five Hundred Ninty) only including GST need be paid through Demand Draft in favour of "The Aska Cooperative Sugar Industries Ltd." Payable at Aska.

The tender should accompany with a bank draft of **Rs.10,000/- (Rupees Ten Thousand) only towards Earnest Money** Deposit through Demand Draft in favour of "The Aska Cooperative Sugar Industries Ltd." Payable at Aska.

The following documents shall be accompanied with the Technical Bid.

1. Cost of Tender Paper Rs.590/- (Rupees Five Hundred Ninty) only non refundable in shape of Bank Draft in favour of the Aska Cooperative Sugar Industries Ltd., on any nationalized bank, Payable at Aska.
2. The EMD of Rs.10,000/- (Rupees Ten Thousand) only in shape of Bank Draft drawn in favour of the Aska Cooperative Sugar Industries Ltd., on any nationalized bank, Payable at Aska, refundable to the tenderer without interest after successful completion of work.

Financial Bid:

1. The rate per MT should be mentioned in the prescribed format

Terms & Conditions:

1. The approximate quantity of filter cake will be $3.5\% \pm 0.5\%$ of the total cane crushing. The expected quantity of filter cake production will be around 2000 tonnes which may vary depending upon the cane crushing. The filter cake so produced will have to be shifted from the filter cake production point to the newly constructed Composting Yard of the Industry situated at a distance of 200 meters approximately. For the said purpose the contractor has to engage two tractors with hydraulic unloader system round the clock and required number of labourers for loading & unloading purpose.
2. The successful bidder must lift the filter cake regularly on daily basis in all the three shifts and ensure that the same is not accumulated at the production chute.
3. Under no circumstances the filter cake remain stored at the collection point in which case the Industry reserves the right to arrange alternative means for lifting / removing of the filter cake on its own and the cost shall be recovered from the contractor at actual from the bills of the Contractor.
4. The facility of the weighbridge shall be provided by the Industry on free of cost to the successful bidder for this particular purpose as per the direction of the Senior Manager Process.
5. Any failure on the part of the successful bidder to comply with the above requirement shall result in forfeiture of the security deposit.
6. The contractor must have valid labour license.
7. The contractor must have been registered with P.F organization and no dues should be outstanding against the contractor pertaining to previous work payable to the PFO in respect of persons engaged for work. He should arrange to deposit the P.F. dues of his laborers engaged for the work with the P.F. Commissioner according to the P.F. Rules
8. He should arrange to deposit the P.F. dues of his labourers engaged for the work with the P.F. Authorities according to the P.F. Rules & submit the ECR chalan for release payment.
9. The contractor shall not engage any person against whom criminal proceedings has been filed/pending in any court.
10. The Industry reserves the right to supervise, monitor the work of the successful bidder.
11. The Industry also reserves the right to cancel any or all tenders or bid at any stage without assigning any reason thereof.
